The Buyer acknowledges and agrees that the Price is quoded on the condition that all signs are ordered, manufactured and delivered/installed at the same time.

 The Buyer acknowledges and agrees that the Price does not include disconnection and connection to the mains power. The Seller recommends that an authorised electricain is used to undertake this work.

 The Buyer acknowledges and agrees that all art work will be supplied in a vectorised format unless otherwise agreed in writing.

 Where more than one Buyer has entered into this agreement, the Buyers shall be jointly and severally liable for all payments of the Price.

 Upon acceptance of these terms and conditions by the Buyer the terms and conditions are binding and can only be amended with the written consent of the Seller.

Time for payment for the Goods shall be of the essence and will be stated on the invoice or any other forms. If no time is stated then payment shall be due seven (7) days following the date of the invoice.

 Payment will be made by cash, or by cheque, or by bank cheque, or by direct credit, or by any other forms day as and duties that may be applicable shall be added to the Price except when they are expressly included in the Price.

- Delivery of Goods

 The Seller shall not be liable for any loss or damage whatsoever due to failure by the Seller to deliver the Goods (or any of them) promptly or at all, where due to circumstances beyond the control of the Seller. 5.5

- If the Seller retains ownership of the Goods nonetheless, all risk for the Goods passes to

The production of these terms and conditions by the Seller is sufficient evidence of the Seller's rights to receive the insurance proceeds without the need for any person dealing with the Seller to make further enquiries.

 The Buyer acknowledges that Goods supplied may exhibit variations in shade, colour, texture, surface and finish, and may fade or change colour over time. The Seller will make every effort to match batches of product supplied in order to minimise such variations but shall not be liable in any way whatsoever where such variations occur.

 The Buyer acknowledges and agrees that the Seller has hereby advised the Buyer that any signs exceeding four and a half metres (4.5m) in height above the ground level should be installed with support stays.

Access
The Buyer shall ensure that the Seller has clear and free access to the work site at all times to enable them to undertake the works. The Seller shall not be liable for any loss or damage to the site (including, without limitation, damage to pathways, driveways and concreted or paved or grassed areas) unless due to the negligence of the Seller.

 Prior to the Seller commencing any work the Buyer must advise the Seller of the precise location of all underground services on the site and clearly mark the same. - Despite anything to the contrary contained herein or any other rights which the Seller may have howscover.

 (a) where the Buyer and/or the Guarantor (if any) is the owner of land, realty or any other asset capable of being charged, both the Buyer and/or the Guarantor agree to mortgage and/or charge all of their joint and/or several interest in the said land, realty or any other asset to the Seller or the Seller's nominee to secure all amounts and other monetary obligations payable under these terms and conditions. The Buyer and/or the Guarantor acknowledge and agree that the Seller (or the Seller's nominee) shall be entitled to lodge where appropriate a caveat, which caveat shall be withdrawn once all payments and other monetary obligations payable hereunder have been met.

Defects

The Buyer shall afford the Seller an opportunity to inspect the Goods within a reasonable time following delivery if the Buyer believes the Goods are defective in any way. If the Buyer shall fail to comply with these provisions the Goods shall be presumed to be free from any defect or damage. For defective Goods, which the Seller has agreed in writing that the Buyer is entitled to reject.  (iv) the continued use of any Goods after any defect becomes apparent or would have become apparent to a reasonably prudent operator or user; or

 (v) fair wear and tear, any accident or act of God; or

 (vi) any vandalism to the Goods.

 (b) the warranty shall cease and the Seller shall thereafter in no circumstances be liable under the terms of the warranty if the workmanship is repaired, altered or overhauled without the Seller's consent.

Intellectual Property

- Where the Seller has designed, drawn or written Goods for the Buyer, then the copyright in those designs and drawings and documents shall remain vested in the Seller, and shall only be used by the Buyer at the Seller's discretion.

- Unpaid Seller's Rights
 Where the Buyer has left any item with the Seller for repair, modification, exchange or for

 received or been tendered the whole of the Price, or the payment has been dishonoured,
